#### V. CONSENT ITEM

The following consent item is expected to be routine and non-controversial and will be acted upon by the Commission at one time without discussion, unless a request has been received prior to the discussion of the matter.

A. LAFCO APPLICATION NO. 2006-08 – FORMATION OF A COUNTY SERVICE AREA (CSA) NO. 24 – HIDEAWAY TERRACE. A request for the formation of County Service Area (CSA) No. 24 located in Denair. The purpose of the CSA is to create a funding mechanism to provide extended County Services for drainage control and landscape maintenance within the storm drainage basin. The CSA boundaries will affect approximately 4.61 acres. (Staff Recommends Resolution No. 2006-18.)

#### VI. PUBLIC HEARING ITEMS

- A. PUBLIC HEARING SOI APPLICATION NO. 2006-03 AND LAFCO APPLICATION NO. 2006-04 SPHERE OF INFLUENCE MODIFICATION TO THE CITY OF HUGHSON. A request to expand the City of Hughson's Sphere of Influence by approximately 900 acres. The proposed sphere expansion area is generally located west of Geer Road from Santa Fe Avenue on the south, to Hatch Road on the north. (Staff Recommends Resolution No. 2006-14.)
- B. PUBLIC HEARING LAFCO APPLICATION NO. 2006-06 EAST "F" STREET CORRIDOR SPECIFIC PLAN REGORGANIZATION TO THE CITY OF OAKDALE.

  A request to: 1) annex approximately 187 acres to the City of Oakdale; and 2) simultaneously detach the territory from the Oakdale Rural Fire Protection District. The boundaries of the proposal includes the north and south sides of the East "F" Street Corridor (State Route 108/120), between Orsi and Stearns Roads on the eastern side of the present city limits. (Staff Recommends Resolution No. 2006-15.)
- C. PUBLIC HEARING SOI MODIFICATION NO. 2006-02 AND LAFCO APPLICATION NO. 2006-07 SOUTH OAKDALE INDUSTRIAL SPECIFIC PLAN REORGANIZATION TO THE CITY OF OAKDALE. A request to: 1) adopt a Municipal Service Review for the City of Oakdale; 2) expand the Oakdale Sphere of Influence by approximately 65 acres; 3) annex approximately 520 acres to the City of Oakdale; and 4) simultaneously detach the territory from the Oakdale Rural Fire Protection District. The general boundaries of the proposal include the South Yosemite Industrial Area between Kaufman and Warnerville Roads, north of Lexington Road and extending north to the present City limits. (Staff Recommended Resolution Nos. 2006-16 and 2006-17.)

### Campaign Contributions

State law (Government Code Section 84308) requires that a LAFCO Commissioner disqualify herself or himself from voting on an application involving an "entitlement for use" (such as an annexation or sphere amendment) if, within the last twelve months, the Commissioner has received \$250 or more in campaign contributions from an applicant, any financially interested person who actively supports or opposes an application, or an agency (such as an attorney, engineer, or planning consultant) representing an applicant or interested participant. The law also requires any applicant or other participant in a LAFCO proceeding to disclose the amount and name of the recipient Commissioner on the official record of the proceeding. Written or oral disclosure can be made at the beginning of the hearing. The law also prohibits an applicant or other participant from making a contribution of \$250 or more to a LAFCO Commissioner while a proceeding is pending or for three months afterward.

Also pursuant to Government Code Sections 56700.0 and 81000 et seq. any person or combination of persons who directly or indirectly contributes \$1000 or more or expends \$1000 or more in support of or opposition to a change of organization or reorganization that has been submitted to the Commission and will require an election must comply with the reporting and disclosure requirements of the Political Reform Act of 1974.
