6. PUBLIC HEARINGS

- A. **LAFCO APPLICATION NO. 2007-04 – HENDLEY CHANGE OF ORGANIZATION TO THE CITY OF HUGHSON (CONTINUED FROM AUGUST 22, 2007).** A proposal to annex approximately 54.4 acres to the City of Hughson. The City has revised the above subject proposal to include three (3) Assessor Parcel Numbers: 018-048-009, 018-048-010, and 018-052-001. The territory is located on the northeast corner of Tully and Roeding Roads, southwest Hughson area. (Staff Recommends Resolution No. 2007-13, Option 2.)
- B. **LAFCO APPLICATION NO. 2007-08 MITCHELL-SERVICE REORGANIZATION TO THE CITY OF CERES.** A proposal to annex approximately 23.48 acres to the City of Ceres and to simultaneously detach the territory from the Ceres Fire Protection District. The territory is located on the southeast end of Ceres, southeast of Mitchell and Service Roads, east of State Route 99, and bound by Turlock Irrigation District's Ceres Main Canal on the west. (Staff Recommends Resolution No. 2007-21.)
- C. **SOI MODIFICATION NO. 2007-04 AND LAFCO APPLICATION NO. 2007-09 - CHANGE OF ORGANIZATION TO THE SALIDA SANITARY DISTRICT (MODESTO CHRISTIAN SCHOOL).** A proposal to amend the Salida Sanitary District's Sphere of Influence by approximately 40.79 acres and subsequently annex the subject territory to the District's service boundary. The subject site is located at 5755 Sisk Road (APN 136-032-011), on the west side of Sisk Road, north of Pirrone Road, in the Salida area. (Staff Recommends Resolution No. 2007-22).

Disclosure Requirements

1. If you wish to participate on a matter before the Commission, you are prohibited from making a campaign contribution of more than \$250 to any commissioner or alternate. This prohibition begins on the date you begin to actively support or oppose an application before LAFCO and continues until three months after a final decision is rendered by LAFCO. No commissioner or alternate may solicit or accept a campaign contribution of more than \$250 from you or your agent during this period if the commissioner or alternate knows, or has reason to know, that you will participate in the proceedings. If you or your agent have made a contribution of more than \$250 to any commissioner or alternate during the twelve (12) months preceding the decision, in the proceeding that commissioner or alternate must disqualify himself or herself from the decision. However, disqualification is not required if the commissioner or alternate returns the campaign contribution within thirty (30) days of learning both about the contribution and the fact that you are a participant in the proceedings.
2. Pursuant to Government Code Sections 56700.1 and 81000 et seq., any person or combination of persons who directly or indirectly contributes \$1,000 or more in support of or in opposition to a change of organization or reorganization that has been submitted to Stanislaus LAFCO and will require an election must comply with the disclosure requirements of the Political Reform Act of 1974 which apply to local initiative measures. These requirements contain provisions for making disclosures of contributions and expenditures at specified intervals.
