# 6. PUBLIC HEARINGS.

# A. <u>LAFCO APPLICATION NO. 2007-04 – HENDLEY CHANGE OF ORGANIZATION</u> TO THE CITY OF HUGHSON.

Marjorie Blom, Executive Officer, informed the Commission of a letter received from the City of Hughson requesting a continuance of this agenda item.

David Chase, Public Works Director, City of Hughson addressed the Commission requesting that this item be continued to the Commission's October 24, 2007 meeting. Dean Wright, LAFCO Counsel, stated he was unavailable for the October meeting, and thus, suggested that the Commission continue the matter to the next available meeting date (December 5, 2007).

Moved by Commissioner Mayfield, seconded by Commissioner Lane and carried with a 5-0 vote to continue the public hearing request for the Hendley Change of Organization to the City of Hughson to the December 5<sup>th</sup> LAFCO Meeting. (Commissioner Saletta was ineligible.)

# B. <u>MUNICPAL SERVICE REVIEW (MSR) NO. 07-02 FOR THE CITY OF WATERFORD AND SPHERE OF INFLUENCE (SOI) NO. 2007-02 MODIFICATION TO THE CITY OF WATERFORD.</u>

Marjorie Blom, Executive Officer, noted that the action before the Commission on this matter would include two separate public hearings.

Staff then presented the proposal for Part 1 - Review and Adoption of the Municipal Service Review for the City of Waterford, recommending approval.

Chair Hawn opened the Public hearing at 6:10 p.m.

Part 2: Marjorie Blom, Executive Officer, presented the proposal for the Sphere of Influence Modification for the City of Waterford.

Chair Hawn opened the Public Hearing at 6:47 p.m.

The Public Hearing was closed at 7:42 p.m.

Moved by Commissioner O'Brien, seconded by Commissioner Lane and carried with a 3-2 vote, that the Commission adopt Resolution 2007-15 (Option 1), approving the City of Waterford's Sphere Modification request to add 1,638 acres to the City's Sphere of Influence. (Commissioners Hawn, Lane and O'Brien voted for the proposal and Commissioners Mayfield and Rouse voted against the proposal; Commissioner Saletta was ineligible.)

### 8. ADDITIONAL MATTERS AT THE DISCRETION OF THE CHAIRPERSON

Chair Hawn requested that Staff schedule a workshop to discuss the establishment of evaluation standards with quantitative measures for urban services, such as fire and police protection, and water and sewer services. LAFCO Counsel Wright and Executive Officer Blom stated they would work together to address this request and report back to the Commission.

- b. Berger Reorganization to the City of Turlock The City is requesting annexation of approximately 1.66 acres, and detachment from the Turlock Rural Fire Protection District. The territory is within a county island area.
- c. Westside Industrial Specific Plan, Phase II The City of Turlock is requesting a Sphere of Influence Amendment to include 627 acres, and subsequent annexation and detachment of the territory from the Turlock Rural Fire Protection District. (The Commission approved the City's Westside Industrial Specific Plan Phase 1 annexation on February 28, 2007.)

a. Annexation request from the City of Ceres of approximately 23.48 acres, located near the southeast corner of Mitchell and Service Roads.
