B. **SOI MODIFICATION NO. 2007-03 AND LAFCO APPLICATION NO. 2007-06 – WESTSIDE INDUSTRIAL SPECIFIC PLAN PHASE II (WISP II) REORGANIZATION TO THE CITY OF TURLOCK.**

Marjorie Blom, Executive Officer, noted that the action before the Commission on this matter would include two separate public hearings.

She then presented the proposal for Part 1 – Review and adoption of the Amended City of Turlock Municipal Service Review (MSR) and Sphere of Influence (SOI) expansion to the City of Turlock.

Chair Hawn opened the Public Hearing at 6:22 p.m.

**FAVOR:** Debbie Whitmore, Deputy Director, Development Services, City of Turlock provided a PowerPoint presentation to the Commission. Dan Madden, Municipal Services Director, City of Turlock; and Doug Sweetland, Director of Economic Development for the Stanislaus Economic Development & Workforce Alliance (The Alliance) also spoke in favor of the proposal.

Tom Durant, 4406 W. Linwood Avenue, Turlock, spoke neither in favor nor in opposition of the proposal. He stated concerns regarding truck traffic on West Linwood Avenue.

Chair Hawn closed the Public Hearing at 6:42 p.m.

Moved by Commissioner Mayfield, seconded by Commissioner Lane and carried with a 4-0 vote (Commissioner Fantazia was ineligible and Commissioner O'Brien was disqualified) that the Commission adopt Resolution No. 2007-19, approving the amended City of Turlock Municipal Service Review (MSR) and Sphere of Influence (SOI) to the City of Turlock.

Marjorie Blom, Executive Officer, presented the proposal for Part 2 - Westside Industrial Specific Plan Phase II (WISP II) Reorganization to the City of Turlock.

Chair Hawn opened the Public Hearing at 6:54 p.m.

Speaking neither for or against the proposal: Tom Durant, 4406 W. Linwood Avenue, Turlock, stated he would contact the City of Turlock to discuss his concerns; and Christine Etchepare speaking on behalf of her mother, Jeannette Barbot, property owner at 3925 W. Linwood, regarding Exhibit A, page 26 of the staff report which lists the wrong landowner.
