

### STANISLAUS LOCAL AGENCY FORMATION COMMISSION

## MINUTES MARCH 24, 2010

The Stanislaus Local Agency Formation Commission met in the Joint Chambers at Tenth Street Place, Basement Level, 1010 10<sup>th</sup> Street, Modesto, California.

#### 6. PUBLIC HEARINGS

# A. SPHERE OF INFLUENCE MODIFICATION NO. 2009-07 AND LAFCO APPLICATION NO. 2009-04 - CITY FACILITIES REORGANIZATION TO THE CITY OF PATTERSON.

Sara Lytle-Pinhey, Assistant Executive Officer, presented the proposal with the recommendation for approval.

Chair DeMartini opened the Public Hearing at 6:08 p.m.

**FAVOR**: Rod Simpson, Community Development Director, City of Patterson; Mike Willett, Public Works Director, City of Patterson; George Logan, Attorney, City of Patterson; and Cleve Morris, City Manager, City of Patterson.

**OPPOSITION**: Charles Ferry, 2818 Olive Avenue, Patterson; Dominic Speno, Villa Del Lago.

**RUBUTTAL**: Cleve Morris, City Manager, City of Patterson.

Chair DeMartini closed the Public Hearing at 7:04 p.m.

Commissioner Goeken made a motion to approve the proposal as submitted by the City and the motion was seconded by Commissioner Saletta. Commissioners DeMartini and O'Brien voted no, therefore, the vote ended in a 2-2 tie. The motion failed, as three votes are necessary to approve a proposal or motion.

Subsequently, it was moved by Commissioner DeMartini, seconded by Commissioner Goeken, and carried with a 3-1 vote, that the Commission adopt Resolution No. 2010-02, modifying the City's request by removing "Area 9" (approximately 115 acres located north of Olive Avenue), and approving the Sphere of Influence Modification and City Facilities Reorganization to the City of Patterson (Commissioners DeMartini, Goeken and Saletta voted for the proposal and Commissioner O'Brien voted against the proposal; Commissioners Chiesa and Freitas were ineligible).

# B. <u>LAFCO APPLICATION NO. 2009-05 - SOUTHEAST INDUSTRIAL</u> REORGANIZATION TO THE CITY OF PATTERSON.

Marjorie Blom, Executive Officer, presented the proposal with the recommendation for approval.

Chair DeMartini opened the Public Hearing 7:27 p.m.

FAVOR: Rod Simpson, Community Development Director, City of Patterson.

**OPPOSITION**: No one spoke.

Chair DeMartini closed the Public Hearing 7:35 p.m.

Moved by Commissioner Goeken, seconded by Commissioner DeMartini, (Commissioners Chiesa and Freitas were ineligible to vote) and carried with a 4-0 vote to adopt Resolution No. 2010-03, approving the Southeast Industrial Reorganization to the City of Patterson.

# C. <u>LAFCO APPLICATION NO. 2009-06 – FORMATION OF COUNTY SERVICE AREA (CSA) NO. 27 – EMPIRE (PHASE 1).</u>

Marjorie Blom, Executive Officer, presented the proposal with the recommendation for approval.

Chair DeMartini opened the Public Hearing at 7:40 p.m.

**FAVOR**: No one spoke. **OPPOSITION**: No one spoke.

Chair DeMartini closed the Public Hearing at 7:41 p.m.

Moved by Commissioner O'Brien, seconded by Commissioner Saletta, (Commissioners Chiesa and Freitas were ineligible to vote) and carried with a 4-0 vote to adopt Resolution No. 2010-04, approving the Formation of CSA No. 27 – Empire (Phase 1).

#### 8. ADDITIONAL MATTERS AT THE DISCRETION OF THE CHAIRPERSON

Chair DeMartini stated that he would like to see the issue of agricultural mitigation addressed in future annexations, especially those that are only residential. He asked what LAFCO would need to do to come up with a policy on future annexations.

Dean Wright, LAFCO Counsel, stated that the County's ag mitigation policies are currently under litigation and there is a concern regarding mitigation focused on one particular land use versus another. Mr. Wright also noted that Yolo County's LAFCO has an ag mitigation policy that all the cities and the county have agreed upon, which is important as the cities and county are LAFCO's constituents.
