**DISSOLUTION OF COUNTY SERVICE AREA NO. 2 (AIRPORT DISTRICT) AND COUNTY SERVICE AREA NO. 3 (RIVERDALE PARK TRACT)**: This proposal was initiated by LAFCO to dissolve County Service Area (CSA) No. 2 (Airport District) and County Service Area (CSA) No. 3 (Riverdale Park Tract). The two CSAs are currently inactive, are not receiving revenue and are not providing services. The dissolutions will not impact services or create any new taxes or fees for residents within the CSA boundaries. CSA No. 2 (Airport District) is located south of Yosemite Boulevard, west of Tioga Drive, north of Hillside Drive and east of South Santa Rosa Avenue. CSA No. 3 (Riverdale Park Tract) is located at the South Carpenter Road and West Hatch Road intersection, south of the Tuolumne River, and north of West Hatch Road with parcels mostly west of the intersection. The proposal was approved by the Local Agency Formation Commission (LAFCO) on April 27, 2016.
