**NOTICE OF PUBLIC HEARING**

**NOTICE IS HEREBY GIVEN THAT** the Stanislaus Local Agency Formation Commission (LAFCO) will hold a public hearing on **Wednesday, March 28, 2018** at a meeting starting at 6:00 P.M. in the Joint Chambers, Basement Level, Tenth Street Place, 1010 10<sup>th</sup> Street, Modesto, California, to consider the following:

- **LAFCO Application No. 2018-01 – Palm Estates and Wenstrand Ranch Sphere of Influence Modification and Change of Organization to County Service Area 19.** - Request to modify the Sphere of Influence and annex approximately 16.27 acres to County Service Area (CSA) No. 19 (Tuolumne-Gratton). The CSA will provide a funding mechanism for the project site's extended services including parks, streetscape, and storm drain maintenance. The project site is comprised of two subdivisions; Palm Estates & Wenstrand Ranch (APNs 024-050-016 & 024-032-023) and is located in the southwest Denair area and is adjacent to the existing CSA 19 boundary (See attached map). LAFCO Staff has determined that under the California Environmental Quality Act (CEQA) Section 15061(b)(3), the proposal is considered exempt as there is no possibility that the proposed change of organization may have a significant effect on the environment.

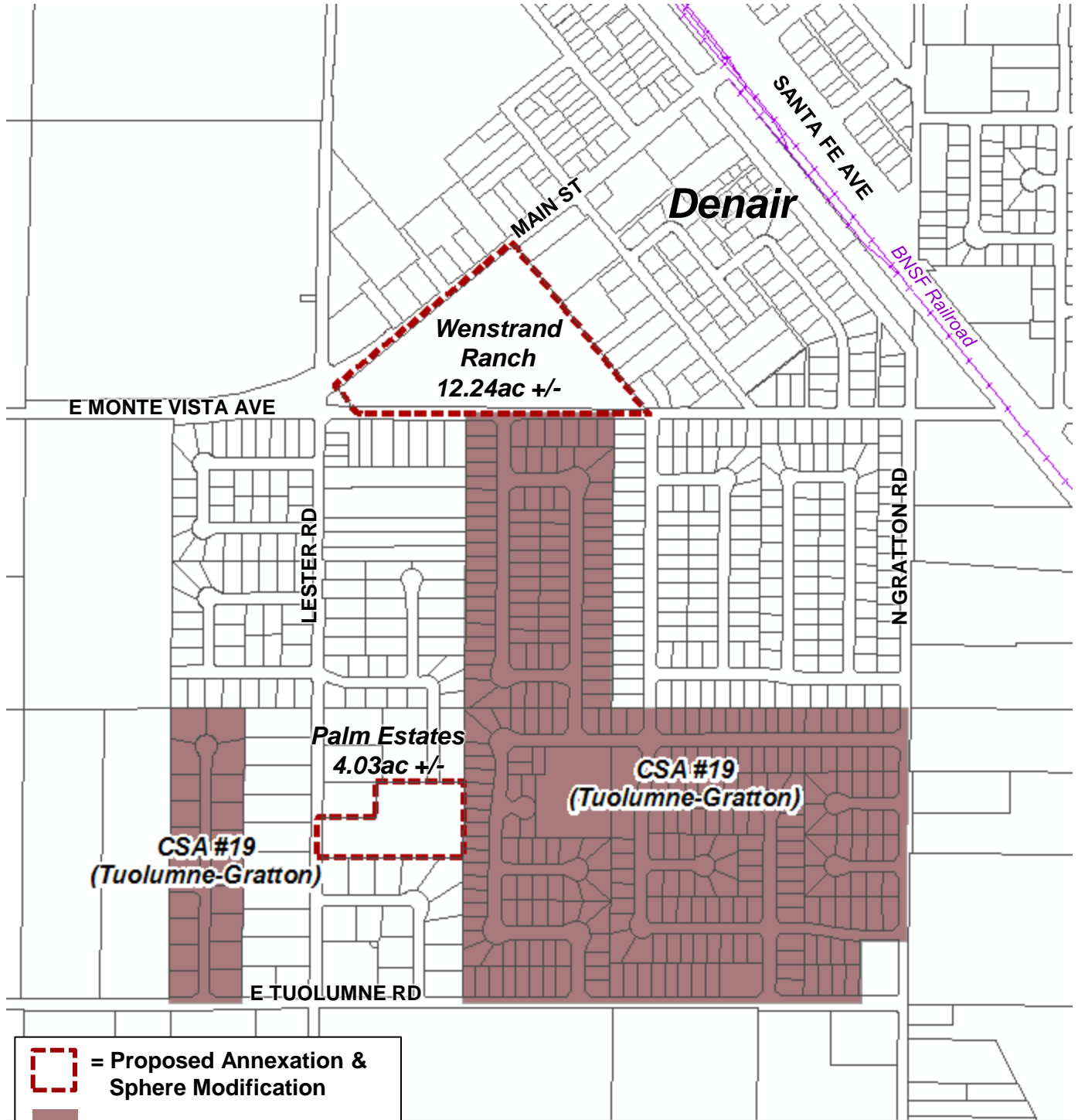
