**NOTICE OF PUBLIC HEARING**

**NOTICE IS HEREBY GIVEN THAT** the Stanislaus Local Agency Formation Commission (LAFCO) will hold a public hearing on **Wednesday, March 25, 2026**, at a meeting starting at 6:00 P.M. in the Joint Chambers, Basement Level, Tenth Street Place, 1010 10<sup>th</sup> Street, Modesto, California, to consider the following:

**LAFCO APPLICATION NO. 2026-01 – ELMWOOD ESTATES CHANGE OF ORGANIZATION TO COUNTY SERVICE AREA NO. 19 (TUOLUMNE GRATTON)**: Request to annex 5-acres to County Service Area No. 19 (Tuolumne-Gratton) for the storm drainage and landscaping of a future subdivision located on the east side of Story Road, between Hillsdale Drive and Walton Street in the Denair area. The annexation to CSA No. 19 will also include a Sphere of Influence amendment. (See attached map for further details).

**This notice is intended to inform you of the proposal and the ability to provide your comments at or prior to Stanislaus LAFCO’s public hearing.** Please be further advised that there is potential for the extension or continuation of a previously authorized charge, fee, assessment, or tax in the annexation area.

Stanislaus County, as Lead Agency under the California Environmental Quality Act (CEQA), approved a Negative Declaration for the project. LAFCO, as a Responsible Agency, will consider the environmental documentation prepared by the County as part of its action.
