This letter is to advise your agency that the above-titled application has been filed with LAFCO. The project is described as follows:

- Description: A request to detach areas from the Central California Irrigation District (CCID) that overlap the current City Limits of Newman. Properties within CCID are typically detached simultaneously upon annexation to the City of Newman. There are currently a number of properties that were not detached, leaving CCID with multiple overlapping areas of properties that are no longer receiving CCID services. Detachment from CCID would eliminate the District/City overlap. (See attached map for further details.)
- Location: All Central California Irrigation District territory that is overlapping the Newman city limits. (See attached map for further details.)
