## **NOTICE OF PROTEST HEARING**

**NOTICE IS HEREBY GIVEN** that on <u>Thursday, September 18, 2025, at 10:00 a.m.</u>, in the Basement Training Room, Tenth Street Place, 1010 Tenth Street, Modesto, California, the Stanislaus Local Agency Formation Commission (LAFCO) will conduct a Protest Hearing regarding:

## LAFCO Application No. 2025-02: Sierra Pointe Change of Organization to the City of Oakdale

<u>Description</u>: A request to annex approximately 304 acres into the City of Oakdale located adjacent to the City limits, south of Highway 120/108, east of Orsi Road and north of Sierra Road. The proposed annexation is for the Sierra Pointe Specific Plan and is within the Oakdale Sphere of Influence. (See attached Map).

<u>Purpose of Protest Hearing</u>: On July 23, 2025, the Stanislaus Local Agency Formation Commission heard and approved the above proposal and adopted LAFCO Resolution No. 2025-11. The Commission's decision is subject to the outcome of a Protest Hearing, where landowners and registered owners can submit their written opposition to the proposal.


<u>How to Protest</u>: Any owner of land and/or registered voter within the affected territory who disapproves of the annexation may file a written protest against the proposal with the Executive Officer at any time **prior to the conclusion of the protest hearing**. A Protest Form is attached for your use. Please be sure include your name, address of land owned within the affected area (if different from your residence), Assessor's Parcel Number and the name of the proposal. Include your signature and the date the signed.

Protest forms can be submitted in the following ways:

- Hand-delivered during the Protest Hearing on Thursday, September 18, 2025, at 10:00
  am in the Basement Training Room, Tenth Street Place, 1010 Tenth Street, Modesto,
  California.

If you are not opposed to the proposed annexation, you need not take any action.
